



The product is produced in Italy, before being transported to Sweden to be sold in the Nordic market.

The end of life reflects the Nordic market, where 3% of plastic waste is landfilled, 48% incinerated with energy recovery and 49% recycled. For the credit for recovered electricity and heat (module D), EU datasets were used.

#### Data

Generic database data was used for the production of raw materials, energy, transportation, packaging and end-of-life. Specific data was collected from the factory.

#### Time representativeness

The site-specific data used for the product manufacturing corresponds to 2021. The age of data from generic databases varies from 2013 – 2022.

### Data quality

All datasets used came from reputable databases GaBi and Ecoinvent, with good technological representativeness and which represent either Sweden or EU28 average. Therefore, it could be considered good.

#### Allocation

No co-product allocation has been applied since no co-products are generated, and therefore allocation has not been relevant.
